**I. U.S. ARMY SECTION, SECRETARIAT, UNITED STATES MILITARY INFORMATION CONTROL COMMITTEE.** 1. *Effective 7 October 1966*, the U.S. Army Section, Secretariat, United States Military Information Control Committee (SF-1300), UIC: WOKJ, is redesignated the U.S. Army Section, Department of Defense Foreign Disclosure Coordinating Office (SF-1300), UIC: WOKJ.

2. Above redesignation is necessitated by a change in unit responsibilities derived from document, 27 September 1966, subject: National Policy and Procedures for the Disclosure of Classified Military Information to Foreign Governments and International Organizations, published by the Department of State, and approved by the Secretary of Defense.

**II. NATIONAL BOARD FOR THE PROMOTION OF RIFLE PRACTICE.** General Orders 14, 1966, is amended as follows:
